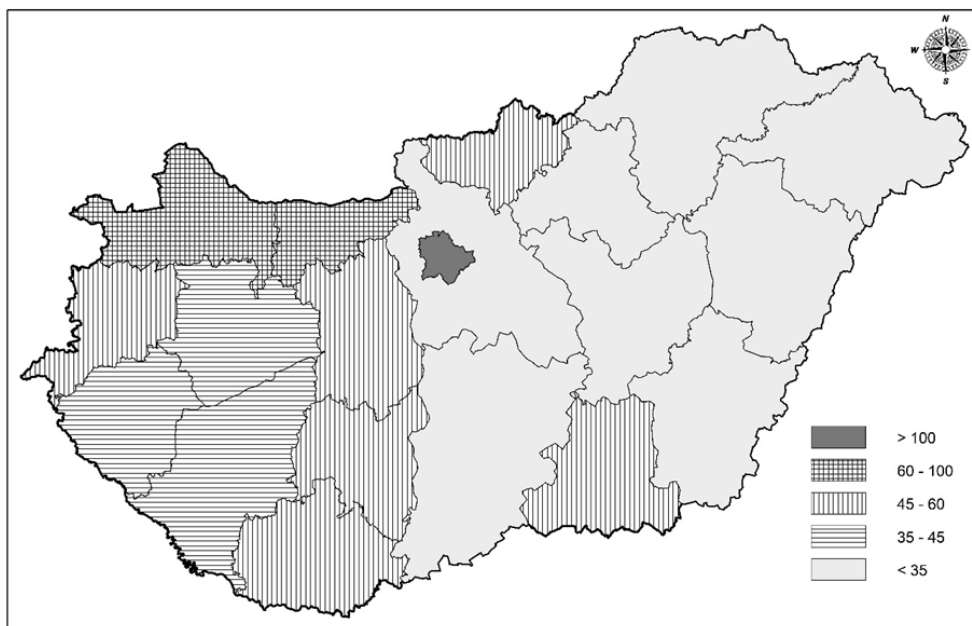


Fig 1: County values of drug-related crimes per 100,000 people (2016–2020) (average: 45.75). Source: Crime Statistics System

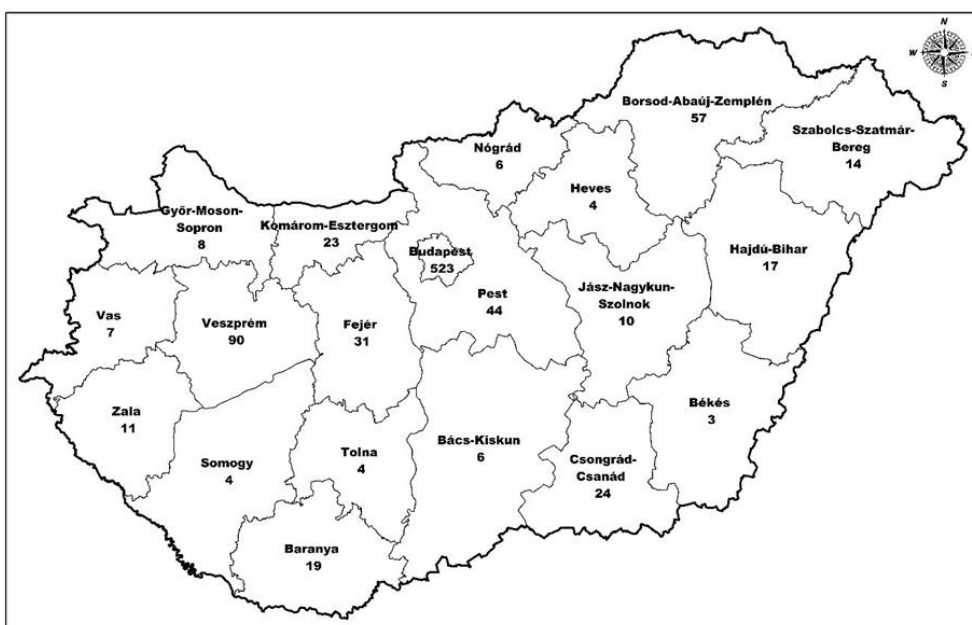


Fig 2: The number of known drug crimes (1980-1989) Database: (Lévai 1991).
